The meeting of the Town of Westover Hills Town Council commenced at 6:01 P.M. Tuesday, January 21 2020, at Westover Hills Town Hall pursuant to written notice posted Friday, January 17, 2020.

1. Call to order.

With a quorum of Town Council Members present, Mayor Kelly Thompson called the meeting to order at 6:01 P.M.

8. Request to Conduct Fireworks.

David Burgess, Police Chief, stated he received a request from a resident that would like to have a fireworks display following a wedding. There was concern generally expressed by Council about allowing fireworks in Westover Hills. Westover Hills is under contract with the City of Fort Worth for fire protection and should follow the Fort Worth fire code with respect to fireworks within the city limits. Mayor Kelly Thompson asked for Chief Burgess to investigate if and how fireworks are allowed in Fort Worth and report back to Council in February.

9. Police Activities Report.

David Burgess, Police Chief, reviewed the 2019 patrol staffing report. Chief Burgess reported that a recently hired police officer had resigned after determining that he was not comfortable in law enforcement. Chief Burgess indicated the job opening has been posted and anticipated that he will receive several applicants as a result of the recent improvement in the retirement plan. Discussion followed about the staffing report results and how many officers were necessary to reach the patrol shift goals. Mayor Kelly Thompson asked Chief Burgess to prepare an analysis to demonstrate how many officers are required to achieve the patrol shift goals taking into effect vacation and sick time.
