# Town Council Meeting Tuesday, February 21, 2023 – 5:30 P.M.

The meeting of the Town of Westover Hills Town Council commenced at 5:30 p.m. Tuesday, February 21, 2023 at Westover Hills Town Hall pursuant to written notice posted Friday, February 17, 2023.

With a quorum of town councilmembers present, Mayor Kelly Thompson called the meeting to order at 5:31 P.M.

# 2. Minutes of the January 17, 2023 Town Council Meeting.

Councilmember John Thompson III made the motion, seconded by Councilmember Elliot Goldman, to approve the minutes of the January 17, 2023 council meeting. The motion carried unanimously

Mayor Kelly Thompson reported the December 2022 and January 2023 financials were not available.

Mayor Kelly Thompson presented the CY2023Q4 Investment Report.

# 7. Ordinance Authorizing Certificates of Obligation Series 2023.

Dan Mahoney of Hilltop Securities presented the result of bids received for the \$2,000,000 Certificates of Obligation offering proposed to be issued by the town in FY2023. Bids were received from six institutions. Amegy Bank submitted the lowest bid with a rate of 3.75% that is callable at any time. Hilltop was pleased with the results of offering and recommends that the town award the issue to Amegy Bank.

Councilmember Marcus Snyder made the motion, second by Councilmember Elliot Goldman, to accept the bid from Amegy Bank, and to adopt Ordinance 23-01 authorizing the issuance and sale of Town of Westover Hills, Texas, Combination Tax and Revenue Certificate of Obligation, Series 2023; levying an annual ad valorem tax; pledging certain net revenues; authorizing the execution of paying agent/registrar agreement; providing an effective date; and enacting other provisions relating to the subject.

A recorded vote was taken. Councilmembers Elliot Goldman, Marcus Snyder, John Thompson III and Steve Tatum each voted "aye" unanimously in favor of the ordinance.

### 8. Public Works Employee Stand-By Policy.

Public Works Director Tim Chambers presented a proposed Employee Standby Program Policy designed to compensate employees designated to be subject to respond to work after normal working hours for emergency events or incidents. The council expressed support of the policy but recommended modifying the milage reimbursement rate to reflect the then current rate published by the Internal Revenue Service. Councilmember John Thompson III made the motion, seconded by Councilmember Marcus Snyder, to approve Resolution 23-02 authorizing the Employee Standby Program Policy subject to the change in milage reimbursement rate. The motion carried unanimously.

# 9. Public Works Activities Report.

Public Works Director Tim Chambers reported the survey results for the purposed location of a new stop sign. Council requested that a stop sign ordinance be placed on the March council meeting agenda.
